**TENNIS COURT
RULES AND REGULATIONS**

COURT RULES:

1. All players are required to have a valid Tennis permit and/or pay the appropriate guest fee. Each player must show his or her permit to the attendant before play. Permit holders must be individuals who reside within the boundaries of the Village of Hastings-on-Hudson or its school district.
2. Permits may be obtained at the James Harmon Community Center (44 Main Street) or the Chemka Pool and are valid from April 1 of the year purchased until March 31 of the following year.
3. If an attendant is not present, players must use the following clock system:

*Players are limited to one hour of play if others are waiting, this includes both singles and doubles.
4. Playing time, when an attendant is present:
 - Players are limited to one hour of play if others are waiting. This includes both singles and doubles.
 - Persons wishing to play **MUST** sign up for the next available court, with the tennis attendant. Courts will be forfeited at the assigned time, if players are not present.
 - Players may remain on the court after the hour of use if no other players are waiting.
5. There are only eight (8) balls allowed on a court at one time.

TENNIS ETIQUETTE:

1. Players are requested to observe tennis etiquette at all times and be considerate of players on adjoining courts.
2. Radios and abusive language are not permitted.
3. Tennis sneakers should be worn at all times.
4. Players are encouraged to keep the courts and surrounding areas clean.
5. Proper tennis attire, including a shirt, is required at all times.
6. Alcoholic beverages are **NOT** permitted anywhere on Village property.

7. Tennis courts are only for the playing of tennis. No skateboards, bicycles or pets are permitted on the courts.

8. If there is no attendant on duty, it is the responsibility of all players to follow all rules and regulations. Any violations can be reported to the Recreation Office with names, dates, times and witnesses. Any Recreation Department staff member has the authority to enforce the rules along with or separate from any attendant on duty.

PERMIT PRIORITY:

1. Adult permit holders have priority at the Hillside Courts from 7:00 a.m. until noon, and again at 5:00 p.m. until dusk.

2. Youth permit holders have priority from 8:00 a.m. to 6:00 p.m. on weekdays, at Reynolds Field courts, from September through June, excluding school holidays.

SPECIAL INFORMATION:

1. Women's Tennis League: April through June – Tuesday mornings 9:00 a.m. until noon, at Hillside when posted. Practices are Thursdays 9:00 a.m. until noon.

2. Tennis Lessons: For more information, please contact the Recreation Department at 478-2380. Tennis lessons may only be given with approval from the Recreation Department. **Permit holders who give paid lessons will be charged a contractual fee by the Recreation Department.**

3. Guest Fees: Players without permits must show proof of residency, and pay the \$10 guest fee.

PLEASE NOTE:

*The Parks and Recreation Department reserves the right to review and alter the tennis regulations at any time should modification be necessary.

* Courts 1 & 2 at the Hillside Park Tennis Courts will be used for lessons. These are the courts furthest from Hillside School.
