#### September 19, 2016 Meeting Minutes

Bruce Levy called the meeting to order at **7:37 pm** in the second floor conference room of the Municipal Building at 7 Maple Avenue, Hastings-On-Hudson, NY on September 19, 2016.

# I. Current Programs and Events:

Village Hall Gallery (VHG):

Bruce Levy re follow-up on the Imagining Architecture show:

Peter Gaito, Jr. of the Westchester AIA committed to cover the show in its Arch Plus newsletter as well as in its 50<sup>th</sup> Anniversary edition in October 2016. The storefront show will be removed on or about October 8, 2016 before the annual Halloween window-painting contest.

The Cristine Kossow pastel painting show called "A Collection of Collections" opening reception on Sunday, September 11 was well attended and well received. One small piece has been sold so far. The show will be removed by October 31, 2016.

Daniel Belasco is the project manager for **The Studio Collective show** that will follow in November and December. Daniel informed Bruce that he will be teaching on Mondays in Oct & Nov and will not be able to make the meetings. He and Lisa have coordinated the opening of the Studio Collective show. Studio Collective will install Nov 1 and the opening will be Sun Nov 6 from 4 - 6 pm.

Lisa & Bruce have a meeting with Susan Maggiotto and Chief Vassali on Wednesday at Village Hall regarding building policy on leaving the lights on over the weekend.

# **II. New Program Planning:**

Susan Soriano reported that the Fitness Gallery Closing went well.

Stuart Wolferman is continuing his conversation with Brooklyn artist Tom Fruin about a proposal to the Board of Trustees for an artful rendering of the water tower at the waterfront.

Bruce is waiting on confirmation of the lead-time for delivery of the fixtures before a start date is set. The work may take 3-4 dys to complete and should be done in September. He will inform Chris Kossow ahead of time so she can cover her work. However, if the schedule runs much later, we may consider delaying the installation till the end of October after the show is removed, and delay the installation of the new show to allow several days in between for the lighting installation without any art works on the walls. Bruce is to check the time frame with the contractor.

Bruce is meeting Steve Zeitlin on Wednesday to further review the "Our Town" Grant Application. Steve registered in grant on 9/12, and the grant is due 9/26.
