DUTIES / TERMS

Choice Words LLC is prepared to begin work immediately to assist the Village of Hastings-on-Hudson with its efforts to seek CFA funding for the following projects:

- 1. Preparation of a Village Wide Drainage Study including the preparation of a watershed map; Stream and watercourse investigation (fieldwork); identification of known issues and possible flooding; survey computer model of watershed and conveyance system; evaluation of existing system and identification of undersized drainage locations, required channel or pipe sizes etc.; conceptual designs and costs and Report with recommendations. Recommended Funding Sources: Green Innovation Grant Program and/or NYS EFC Wastewater Infrastructure Engineering Planning Grant Program
- 2. Surveying, measuring and conditions report of trails, footpaths naturally built stairs and the analysis and preparation of a plan to restore, repair and improve those paths to enhance pedestrian movement in the Village. *Recommended Funding Source: OPRHP Recreational trails program.*

Choice Words will work closely with Mary Beth Murphy and members of the Hastings-on-Hudson team to develop and file two strong CFA applications. This effort will include:

- Registering the projects for all appropriate funding sources on the CFA portal
- Seeking (and, in some cases, writing drafts of) letters of support from local, regional, state and federal representatives and business leaders
- Developing budgets that accurately represent the scope and cost of the projects
- If necessary, assisting with the formulation of a presentation before the REDC during Priority Project review
- Researching, writing and filing a complete and competitive CFA submission approved by the Village of Hastings-on-Hudson team and submitted on or before the announced deadline.

COMPENSATION

Choice Words would accomplish this work for the Village of Hastings-on-Hudson for a project fee of \$7,500 for the first CFA and \$5,000 for the second CFA, for a total of \$12,500 for two CFAs. Prior to beginning work on this project, Choice Words would bill the Village of Hastings-on-Hudson for one half of the total project cost (\$6,250), with the remaining \$6,250 due upon completion and filing of the CFAs. Choice Words would seek reimbursement of customary expenses—i.e. mileage, copies, etc.—only if preapproved by Mary Beth Murphy and/or appointed designees.
