PROPOSED LOCAL LAW C OF 2018

A LOCAL LAW Amending Chapter 295 Zoning to delete certain provisions Relating to Zoning Board of Appeals procedures

Be it enacted by the Board of Trustees of the Village of Hastings-on-Hudson as follows:

SECTION 1. Section 295-141, Referral to Planning Board, is hereby deleted and amended to read as follows:

295-141 (Reserved)

SECTION 2. Section 295-144.G., is hereby deleted.

SECTION 3. SEVERABILITY

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

SECTION 4. EFFECTIVE DATE

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
