87:17 ADOPTION OF LOCAL LAW NO. 4 OF 2017

RESOLVED:

that the Mayor and Board of Trustees hereby adopt Local Law No. 4 of 2017 to amend Article VII Stop and Yield Intersections of Chapter 282 Vehicles and Traffic of the Code of the Village of Hastings-on-Hudson to add a stop signs at the intersection of Branford Road, The Fenway and Fenwick Road.

Be it enacted by the Board of Trustees of the Village of Hastings-on-Hudson as follows:

SECTION 1. Section 282-16.A.(13) of the Code of the Village of Hastings-on-Hudson is hereby amended to read as follows:

§282-16.A.(13) The intersection of The Fenway, Fenwick Road and Branford Road is hereby designated as a four-way stop intersection and a stop sign shall be erected on each street where they intersect.

SECTION 2. SEVERABILITY

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

SECTION 3. EFFECTIVE DATE

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

88:17 – ACCEPT DEDICATION OF THE OPEN SPACE PARCEL AT SAW MILL LOFTS
