## 28:24 SUPPORT FOR THE NEW YORK STATE ASSEMBLY AND SENATE TO PASS A STRONG PACKAGING REDUCTION AND RECYCLING INFRASTRUCTURE ACT (A.5322-A/S.4246-A) AND EXPAND THE STATE'S BOTTLE BILL (A.6353/S.237-B)

Trustee Fleisig moved, seconded by Trustee Drake, that the following resolution be approved: Approved 5-0.

**WHEREAS,** packaging makes up approximately 40 percent of the waste in New York

State; and

**WHEREAS,** managing packaging waste costs New York taxpayers hundreds of millions

of dollars annually; and

WHEREAS, some packaging is not recyclable and reusable and refillable packaging

systems are not readily available; and

**WHEREAS,** plastic causes serious pollution including litter and use of toxic chemicals;

and

**WHEREAS,** companies that produce packaging should help bear the costs of packaging

waste, not just taxpayers; and

WHEREAS, enacting the Packaging Reduction and Recycling Infrastructure Act, as

drafted in the New York Assembly A.5322-A and the New York Senate S.4246-A, would reduce waste, increase recycling rates, create jobs, reduce toxicity in products, provide millions of dollars in savings for local governments and taxpayers, and lower greenhouse gas emissions; and

**WHEREAS,** the Packaging Reduction and Recycling Infrastructure Act should work in

tandem with and supplement New York State's Returnable Container Act;

and

**WHEREAS**, New York's Returnable Container Act should be modernized to reflect an

expanded market of beverages, and the deposit on beverage containers

should be increased to 10 cents;

THEREFORE BE IT RESOLVED, that Hastings-on-Hudson urges the New York State

Legislature to pass and Governor Kathy Hochul to sign into law a strong and effective Packaging Reduction and Recycling Infrastructure Act A5322-A/S4246-A, and an expanded and modernized Bottle Bill

A.6353/S.237-B; and

RESOLVED,

further, that Hastings-on-Hudson shall forward copies of this resolution to Governor Kathy Hochul, the New York Assembly Speaker Carl Heastie, New York State Senate Majority Leader and our State Senator Andrea Stewart-Cousins, Assemblymember Shimsky and all others deemed necessary and proper.

#### 29:24 RESOLUTION CALLING FOR AN INCREASE IN AIM FUNDING

Trustee Drake moved, seconded by Trustee Alligood, that the following resolution be approved: Approved 5-0.

WHEREAS, the Aid and Incentives for Municipalities (AIM) program plays a critical

role in funding essential municipal services for cities and villages across

New York State; and

**WHEREAS,** city and village officials share the same priorities as our state leaders which

is to make New York safer and more affordable; and

WHEREAS, New York's local governments, who are on the frontlines of controlling

property tax affordability and ensuring public safety, are integral to

achieving those goals; and

**WHEREAS,** the State has not increased AIM funding in 15 years and according to the

Bureau of Labor Statistics, inflation has increased by nearly 45% during

that same period; and

WHEREAS, this neglect from the State has led to rising municipal tax burdens and

harmful disinvestment in essential municipal services and staff; and

WHEREAS, the property tax cap further limits the ability of local governments to

properly fund the services their residents need; and

**WHEREAS,** the challenges of rising inflation, the increasing costs of labor and supplies,

and the end of extraordinary federal aid, only accentuate the need for an

increase in AIM funding; and

**WHEREAS,** the Governor's 2024-25 Executive Budget proposes to keep AIM funding

flat; and

**WHEREAS**, an increase in AIM funding would reduce the local tax burden and help

revitalize communities across New York;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Board of Trustees of the Village

of Hastings-on-Hudson urge Governor Hochul to work with the leaders of the Senate and Assembly and increase AIM funding in the 2024-25 adopted

State Budget.

A copy of this resolution shall be sent to Governor Kathy Hochul, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Assemblymember MaryJane Shimsky, and the New York State Conference of Mayors.

Mayor Armacost reminded the Village Board and members of the public that a public workshop on the Route 9 Complete Streets project will be held on March 7, 2024, from 6pm – 8pm at the Tarrytown Recreation Center.

Mayor Armacost reminded the Village Board and members of the public that the Hillside Woods Deer Push is on March 16, 2024 at 10am. Volunteers will meet at the Hillside School Cafetorium. Pre-registration is required and can be found online.

Mayor Armacost introduced a discussion regarding potential incentives for landscapers to switch to electric leaf blowers. The Village Board discussed the criteria, including landscaper application for the incentive, as well as the funding source.

Mayor Armacost announced to the Village Board and members of the public that she has reregistered the Village to be part of the Mayor's Monarch Pledge, supporting the monarch butterfly. Mayor Armacost offered thanks to the Conservation Commission, the Beautification Commission, and the Pollinator Pathway group for their work in achieving the pledge items necessary for the Village to apply.

Mayor Armacost provided a recap on recent events and announced the upcoming schedule of events.
