### **APPROVAL OF MINUTES**

Trustee Lopez moved to approve the minutes for the Public Hearing on Proposed Local Law C of 2020, May 5, 2020, the Public Hearing on Proposed Local Law D of 2020, May 5, 2020, the Public Hearing on Proposed Local Law E of 2020, May 5, 2020, and the Regular Meeting of the Board of Trustees May 5, 2020, seconded by Trustee Fleisig. ### **PRESENTATIONS**

Marilyn Dare of NYSDERA and Mike Dewein, a consultant for NYSERDA, provided a detailed presentation on the New York Stretch Energy Code. A discussion with the Village Board followed.

Sarah Smiley of EIC New York provided a detailed presentation on PACE (Property Assessed Clean Energy) financing. A discussion with the Village Board followed.

## **PUBLIC COMMENT**

Village Manager Murphy read aloud the following emailed comment submitted by Mr. Paul Molinari:

Honorable Mayor and Trustees

Tonight I want to address two areas - stormwater management (being discussed later) and the Village's policy for public comment.

The Village needs to improve its public outreach on stormwater in two areas - curbing of dog waste and dumping of oil, antifreeze and vehicle fluids. Since moving to this lovely Village, on my daily walk in the downtown, I have noticed dog waste on the sidewalks and hardly any signs reminding individuals to curb their dog. Some residents have posted their own signs to curb their dog. The Village needs to install signs throughout the Village on curbing your dog, what the fine is and cite the Village code. Secondly, this past fall I noticed an individual on Maple Avenue dumping buckets of what appeared to be antifreeze (green fluid) into the street. The stream was about one foot wide and 200 feet long draining into the storm drain at the corner of Maple and North. Not knowing who to report this activity, I reported it to the Police department. I was informed that it's only a crime if it is more than five gallons. However the officer agreed to dispatch an officer to warn the individual. In my experience, any disposal of pollutants, in this case car fluids, is a violation of the Clean Water Act and the municipal stormwater program. I would recommend that the Village each year mail to all residents a flyer explaining the stormwater requirements and install signage by each stormwater drain that it goes to a waterbody.

The second issue is the Village's policy for public comment. In my opinion, the time limit of three minutes is overly restrictive, especially if a resident wants to present an issue, potential solutions and also comment on the resolutions. I recommend that the limit for public comment be increased to five minutes. I also recommend that a separate public comment period be established to address the resolutions. I recommend the time frame to comment on the resolutions be five minutes with a maximum limit of ten minutes.

# 50:20 RESOLUTION FOR LOW- EMBODIED CARBON CONCRETE FOR BUILDING AND INFRASTRUCTURE PROJECTS IN THE VILLAGE OF HASTINGS-ON-HUDSON

Trustee Lambert moved, seconded by Trustee Fleisig, and unanimously carried upon roll call vote, that the following resolution be approved: Approved 4-0.

WHEREAS,

there is scientific consensus regarding the reality of climate change and recognition that the emission of greenhouse gasses from human activity and the construction of the built environment are significant drivers of climate change; and

WHEREAS,

the Intergovernmental Panel on Climate Change, an intergovernmental body of the United Nations that is dedicated to providing the world with an objective, scientific view of climate change, reported in 2013 that the last 30 years were the warmest since 1850 and likely the warmest in the past 1,400 years, and that the current decade is set to be the hottest on record; that carbon dioxide, methane, and nitrous oxide levels are at their highest levels in 800,000 years; and that global mean sea level rose 0.62 feet from 1901 to 2010 and continues to rise; and

WHEREAS,

the Village of Hastings-on-Hudson is committed, through its Sustainability Action Plan, commitment to the Paris Climate Agreement and the Global Covenant of Mayors for Climate & Energy, and adoption of the New York State Climate Smart Communities pledge, to implement policies and undertake all possible measures to reduce its contribution to human caused climate change, including reducing greenhouse gas emissions; and

WHEREAS,

embodied carbon refers to the carbon emissions generated as a result of the manufacturing and transportation of materials and the construction of building and infrastructure projects; and

WHEREAS,

concrete is the most widely used construction material in the world because of its low cost, strength, and durability, among other factors, and is a significant component of all building and infrastructure projects, including those of municipalities; and

WHEREAS,

cement, the critical ingredient that gives the concrete its strength, is responsible for up to seven percent of the world's carbon dioxide emissions, mainly through a chemical process called calcination, as well as through the use of energy in production derived from the combustion of fossil fuels; and

WHEREAS,

low-embodied carbon concrete is defined as concrete that has been verified, as measured by a Global Warming Potential (GWP) metric, to embody lower carbon emissions as compared to the baseline embodied carbon emissions of conventional concrete; and

WHEREAS,

lowering the embodied carbon emissions from concrete can be achieved through diverse methods and processes, including but not limited to: (A) using less cement in concrete mixes; (B) replacing or substituting cement with supplemental cementitious materials (SCMs) such as fly ash, blast furnace slag, or ground glass pozzolan; (C) using locally produced cement and other concrete components resulting in reduced emissions from transport; (D) the utilization and mineralization of carbon in concrete materials; and

WHEREAS,

the quality of concrete may be improved through these techniques, the cost compared to traditional methods is offset by lower materials cost, and the use of low-embodied concrete is established in the construction sector and has been successfully utilized for the construction of building and infrastructure projects by several municipalities; and

WHEREAS,

the annual benefits of the use of this concrete in New York State, if universally adopted would be the equivalent to the carbon sequestration for tens of thousands of acres of preserved forest; and

WHEREAS,

the Village of Hastings-on-Hudson has the opportunity to be a leader in New York State in promoting the use of this technology; therefore, be it

**RESOLVED:** 

that the Village of Hastings-on-Hudson encourages, and will work to promote, the use of low embodied carbon concrete products in building and infrastructure projects involving concrete, where the utilization of low embodied carbon concrete does not significantly increase the costs of or delay project completion, and where utilization does not compromise either construction integrity or public safety. Such promotion could include, but may not be limited to,

identifying local low embodied carbon concrete product options, making embodied carbon concrete educational materials more accessible, recognizing local projects utilizing low embodied carbon concrete products, and sharing Hastings-on-Hudson's program successes and lessons learned with other towns and local governments in the state and region.
