### **New Member**

We unanimously welcomed Sashi as a new member of the commission and will set him up with Niki to formalize his membership.

#### **Route 9 Corridor**

Hastings, Dobbs, Irvington, Tarrytown and Sleepy Hollow.

Andy spoke in front of BOT two weeks ago to give an update, which went well, and will seek their support going forward for the next phase. Funding will be required for a detailed engineering; so far only a general plan has been outlined. Study was state-funded, as Broadway is a state road. State is supportive bc of Broadway being a bike-through, plus bc it will hook up to the Tappan Zee Bridge. There will be cost estimate, parking etc. ironed out. In 2.5 weeks the steering committee – 3 reps from each village – will host a public stakeholder session for BOTs plus open houses for the public. New striping near Frasier Place, Shadowlawn on Broadway a result of public feedback. Temporary cones will be placed before work takes place. Working closely with Transportation Working Group.

Some grant funding sources have been identified. Jean will give Andy some introductions to folks she knows. Meanwhile Andy will continue to work to keep all the villages happy and working well together.
