# Hastings-on-Hudson Recreation Department HALLOWEEN WINDOW PAINTING OFFICIAL RULES 

Applications must be submitted to the Recreation Department no later than Thursday, October 18, 2018.

REMEMBER, THE ROADS WILL BE OPEN PLEASE WATCH FOR TRAFFIC!!!

1. This event is on a first come, first served basis to anyone who resides in the Village of Hastings-on-Hudson and the Hastings-on-Hudson School District.
2. Window Painting will take place on:

Saturday, October 20 from 10:00 a.m. - 2:00 p.m.
3. Entry fees are as follows: Pre-K entry- $\$ 2.00$
single entry - $\$ 5.00$
team entry - $\$ 7.00$
4. Eligibility- Pre-K-3 \& 4 year old children who would like to take a picture of poster board.
Single-Children in grades $\mathrm{K}-12^{\text {th }}$.
Team- Up to 4 children in grades $\mathrm{K}-12^{\text {th }}$.
5. Up to four participants may be on a team, and only those participants may paint their assigned window space.
6. The Hastings Recreation Department will distribute paint on Saturday, October 20 at the James Harmon Community Center, Main Street between 10:00am-1:00pm.
7. Participants may ONLY use the paint given out by the Recreation Department. Contestants using any other materials will be disqualified.
8. EQUIPMENT- The Recreation Department will only provide paint: contestants must bring all other supplies. The following is a list of required supplies:
a. Paint brushes, sponges, etc.
b. Containers for mixing colors, water, and cleaning brushes.
c. Blue painters tape, newspaper for protecting painted storefronts and brickwork.
d. Rags for cleaning brushes, spilled paint, etc.
e. A sturdy garbage bag for rags, paper, etc. Contestants who leave a mess will jeopardize any future participation in the Window Painting Event.

## 9. SOLID BLACK, DARK BLUE OR GRAY BACKGROUNDS ARE NOT PERMITTED (solid backgrounds may crack the window).

10. Participants must stay inside the black lines on the window.
11. Participants may seek advice for their designs, but the actual painting must be done by the participants only. NO STENCILS MAY BE USED FOR ANY REASON, including pre-cut materials for tracing.
12. Participants may only paint the window to which they were assigned. Participants painting a window not assigned to them will lose the right to paint a window.
13. Parents may help their child(ren) in masking off the window/brickwork but are asked to let their children do the painting.
14. ALL paintings should be of good character and taste and have a Halloween theme.
15. Participants will be disqualified for paint on sidewalks, brickwork or any other area but the Merchant's window. Also, failure to cover non-glass areas with newspaper before painting will result in disqualification. Please be respectful of the merchants' property - KEEP CLEAN!
16. Rain Date will be October $27^{\text {th }}$.
17. Merchants reserve the right to remove paintings on or before the Recreation Department's clean-up date.
