**36 Calumet Avenue** (Carried over from the meeting held on February 27, 2014)

Relief from the strict application of Section 295-68F.(2)(a)[2] of Village Code for construction of a swimming pool in the backyard of their house at 36 Calumet Avenue. The variance sought is as follows:

1 Development Coverage: Existing/Proposed – 40.54%/42.32%; Permitted Maximum – 35%{295-68F.(2)(a)[2]}

 44 Clunie Avenue

 Relief from the strict application of Sections 295-99.F.(1).a., 295-99.F.(1).c. and 295-99.F.(2).a.(1) for the addition of a second story on an existing single story home at 44 Clunie Avenue.

 The variances sought are as follows:

 1. Front Yard: Existing and Proposed – 19.6 ft.; Required – 25 ft.; {295-99.F.(1).a.}

 2. Side Yard – (One Side Minimum/Two Sides Total): Existing and Proposed – 5.72 ft./18 ft.; Required – 8 ft./20 ft.; {295-99.F.(1).c.}

 3. Development Coverage: Existing and Proposed – 46.6%; Permitted Maximum – 40% {295-99.F.(2).a.(1)}
