Dear Mayor Armacost and Members of the Village Board of Trustees:

On behalf of Electric Owl Holdings, LLC (the "Applicant"), we respectfully submit this letter in furtherance of the pending Application and to supplement the most recent letters submitted by Cuddy & Feder LLP on behalf of Electric Owl Holdings, LLC (the "Supplemental Letters") on November 22, November 30, December 4, and December 12, 2023.

At the request of Ms. Mary Beth Murphy, Village Manager, we respectfully confirm that the Applicant is committing to install a sidewalk along the westerly side of South Broadway from the bus stop southerly of the driveway and continuing to the northern end of the Site, including a sidewalk accessing the School. Enclosed is a copy of a plan prepared by Kimley-Horn Engineering and Landscape Architecture of New York, P.C. entitled, "Overall Site Plan" that has been highlighted in yellow to show the location of the proposed sidewalk to be installed.

Please note that we do not anticipate or project any pedestrian traffic along the segment of South Broadway between the bus stop and Dudley Street, which primarily is situated in the City of Yonkers. Accordingly, we respectfully submit that there is no need for a sidewalk as mitigation for any pedestrian traffic in that area. Nevertheless, the Applicant is willing to install a sidewalk in that area along South Broadway, if the Village requests it and, further, if it is permitted by the governmental agencies having authority for approval thereof.

We respectfully request that this letter and its enclosures be incorporated in the official record of
