**RESOLUTION**

On motion of Trustee Lopez, seconded by Trustee Lambert the following Resolution was duly adopted:

**82:23 RESOLUTION DEDICATING PARKLAND IN THE VILLAGE OF HASTINGS-ON-HUDSON**

**WHEREAS,** the Village of Hastings-on-Hudson has previously dedicated a series of properties as public parkland, either by deed or official resolution, including:

MacEachron Park (4.30-19-7);	Nepera Park (4.150-155-4);
Pulver's Woods (4.110-108-62);	Fraser Park (4.110-105-5);

**WHEREAS,** these dedicated properties total 156 acres, or 84% of all the open space owned by the Village (excluding rights of way), and more than 8% of the 1,882 acres comprising the Village as a whole; and

**WHEREAS,** the Village of Hastings-on Hudson owns additional lands which are not currently dedicated as public parkland,

**NOW THEREFORE BE IT RESOLVED,** that the Board of Trustees determines that the dedication of previously-acquired property as parkland is a Type II action under the State Environmental Quality Review Act, not requiring additional environmental review; and

**BE IT FURTHER RESOLVED**, that the Board of Trustees of the Village of Hastings-on-Hudson hereby agrees to maintain and improve the following lands as dedicated public parks, to be under the care and control of the Trustees of Hastings-on-Hudson:

Quarry Park (4.70-58-1);  
Graham Park Additions (4.130-138.13.1; 4.130-139-25, 4.160-166-4, 4.160-167-5, 4.160-167-6);  
Ferndale Park (4.40-36-6);  
Mount Hope Park (4.90-90-6);

**BE IT FURTHER RESOLVED**, that the Village has now dedicated 164 acres, or 89% of all the open space owned by the Village (excluding rights of way), and more than 8% of the 1,882 acres comprising the Village as a whole.


