RESOLUTION

On motion of Trustee Drake, seconded by Trustee Lopez the following Resolution was duly adopted:

86:23 ADOPTION OF PROPOSED LOCAL LAW A OF 2023, A LOCAL LAW AMENDING CHAPTER 282 VEHICLES AND TRAFFIC, ARTICLE VIII SPEED REGULATIONS, TO AMEND THE MAXIMUM SPEED LIMITS IN THE VILLAGE

RESOLVED: that the Mayor and Board of Trustees hereby adopt Proposed Local Law A of 2023, A Local Law Amending Chapter 282 Vehicles and Traffic, Article VIII Speed Regulations, to Amend the Maximum Speed Limits in the Village as follows:

A LOCAL LAW TO AMEND CHAPTER 282 VEHICLES AND TRAFFIC ARTICLE VIII SPEED REGULATIONS OF THE CODE OF THE VILLAGE OF HASTINGS-ON-HUDSON REGARDING THE SETTING OF SPEED LIMITS ON VILLAGE STREETS AND PUBLIC ROADWAYS

Be it enacted by the Board of Trustees of the Village of Hastings-on-Hudson as follows:

Section One. Section 282-17 subsection A of the Code of the Village of Hastings-on-Hudson is hereby amended to read as follows:

- A. In accordance with the provisions of New York Vehicle and Traffic Law Section 1643, the maximum speed limit at which vehicles may proceed on highways within the Village is twenty-five miles per hour, except as provided in Subsection B and C below.

Section Two. Section 282-17 subsection B of the Code of the Village of Hastings-on-Hudson is amended to read as follows:

- B. The maximum speed limit on State and County highways within the Village shall be as posted.

Section Three. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section Four. Effective Date

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

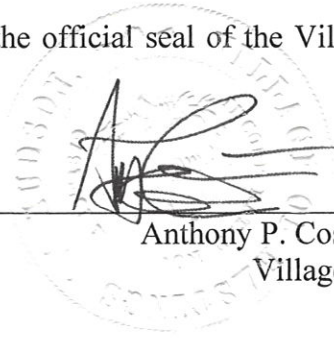
