Current Programs and Events

I. Village Hall Gallery Update - 2024 to 2025

November 2023 - January 2024

People, Race and Power - Open Call, Multi-Artist Exhibition

Part of the Mamie and Kenneth Clark Project

Daniel Belasco and Susan are the lead project managers for HVAC.

This is our partnership with Hastings Historical Society

The exhibition title is derived from the book, "Children, Race, and Power" about the Clarks' Northside Center in Harlem, NY.

Clark Sub Committee meeting on January 18 @ 7:30pm was canceled and will be rescheduled for a date TBD in February or March by Susan Soriano and Daniel Belasco. They will draft the production timeline for the open call, then reconvene with the other HVAC project members;

Dan Markham, Mary, and Bruce, on next steps, assigned roles, coordination with Historical Society and other partners.

II. New Program Planning

Floral Exhibition

Susan and Bruce presented this exhibition idea for 2025 after scouting the RiverArts Studio Tour. Artists seen whose work could be considered might be Jen Moore Smith, Raine Gifford, and Nora Galland. NJD suggested Susan Richman's work. Idea to be further developed by Susan and Bruce.

Bruce and Sal presented this event idea, possibly to include advice or participation by Ann van Buren, Steve Zeitlin, with The Good Witch Cafe proposed as a venue. To be researched.

Cynthia Smith

This HoH artist approached NJD who shared images of her artwork with the commissioners. Smith invited commissioners to visit her studio and consider her work for an exhibition in 2025. Mary expressed interest and NJD will follow up with the artist.

Connecting Three Generations

Susan suggested this concept and will reach out to artists she has in mind who knew each other and were inspired by each other, to inquire of their interest in participating.

Rotating Outdoor Sculpture Exhibitions (ROSE)

The Commission received a request to consider hanging one of Madge Scott's artworks permanently in one of the Village's publicly accessible buildings.
