LOCAL LAW 7 OF 2019

A LOCAL LAW Amending

Chapter 209 Parks and Recreation to Reorganize Existing Provisions and Add New Language Reflective of Current Practices.

Be it enacted by the Board of Trustees of the Village of Hastings-on-Hudson as follows:

SECTION 1. Section 209-2, Charges and rules for use, of Chapter 209, Parks and Recreation, of the Code of the Village of Hastings-on-Hudson, is hereby amended as follows:

§ 209-2. Charges and rules for use.

The Village of Hastings-on-Hudson is hereby authorized to impose rules and collect charges for the use of the swimming pool and related facilities, all in accordance with the fees and rules to be determined by the Village Board by resolution and set in the fee schedule, which may be amended from time to time at the recommendation of the Parks and Recreation Commission.

SECTION 2. Section 209-4, Guest passes, of Chapter 209, Parks and Recreation, of the Code of the Village of Hastings-on-Hudson, is hereby amended as follows:

§ 209-4. Guest passes.

The Parks and Recreation Commission is hereby empowered to permit guest privileges for use of the pool facility. The number of guests, their qualifications, and the times of admittance to and use of the pool shall be set by the Parks and Recreation Commission on an annual basis for each season. The charge for each guest shall be determined by the Village Board by resolution and set in the fee schedule.

SECTION 3. Section 209-19, Penalties for offenses, of Chapter 209, Parks and Recreation, of the Code of the Village of Hastings-on-Hudson, is hereby amended in its entirety as follows:

§ 209-19. Penalties for offenses.

Any person who violates any provision of this article shall be punished subject to the penalties prescribed by §1-13 of the Village Code.

SECTION 4. There is hereby added a new Article V, Sales in Public Parks and Playgrounds, within Chapter 209, Parks and Recreation, of the Code of the Village of Hastings-on-Hudson, to read as follows:

Article V Sales in Public Parks and Playgrounds

§ 209-20. Permit required.

No person shall sell or offer for sale any object or merchandise in any public park or playground of the village except under a written permit by the Village Clerk, and then only at the place or places designated in the permit.

§ 209-21. Licensing and fees.

All persons wishing to sell wares in a public park or playground shall complete an application as created by the Village Clerk and pay such a fee as set by resolution of the Village Board and placed in the fee schedule.

§ 209-22. Penalties for offenses.

Any person who violates any provision of this chapter shall be punished subject to the penalties prescribed by §1-13 of the Village Code.

SECTION 5. There is hereby created a new Article VI, Tennis and Day Camp Regulations, within Chapter 209, Parks and Recreation, of the Code of the Village of Hastings-on-Hudson, to read as follows:

Article VI Tennis and Day Camp Regulations

§ 209-23. Tennis permits.

A. Charges.

- (1) Charges for tennis permits, per season, for adults and children are to be determined by the Village Board by resolution and set in the fee schedule.
- (2) A guest must be accompanied by a permit holder, with a charge to be determined by the Village Board by resolution and set in the fee schedule.

B. Regulations.

- (1) All players are subject to the rules and regulations adopted by the Parks and Recreation Commission.
- (2) A tennis permit entitles the permit holder to use the public tennis courts operated by the Village of Hastings-on-Hudson, New York.

§ 209-24. Day camp.

Charges, per season, are to be determined by the Village Board by resolution and set in the fee schedule.

SECTION 6. SEVERABILITY

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

SECTION 7. EFFECTIVE DATE

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
